# 57. North Lincolnshire Ward Councillors' Report and Councillors' questions to Ward Councillors.

#### Cllr C Sherwood

Following the walk around with Mick Johnson, NLC highways manager, on 6<sup>th</sup> October 2023 the update was received ..

Road surface A18 through Wrawby is due for resurfacing in two stages over the next financial year or two dates to be confirmed.

The dwarf wall is not a retaining wall and so structurally not an issue, will look to remove loose bricks shortly with repairs next year.

The footpath leaving Wrawby has been assessed by the contractor and works agreed dates to be confirmed, once completed we will look to undertake surface treatment.

The verge corner at Kettleby Lane is at the original level and will receive no work at this time.

Patching for Kettleby Lane is programmed for after Christmas.

9<sup>th</sup> /10<sup>th</sup> December Normanby Hall Christmas Market. Pleased to report that visitor numbers have increased from 140,000 per year in 2018 to 180,000 so far in 2023.

Bin collection notices are now on line but can be printed by request at one of the NLC wellbeing hub. Also requesting that Town and Parish Councils will post in the notice boards and online.

Cashless Parking machines are being rolled out across North Lincolnshire. Can use debit or credit cards as well as the App.

3 Councils – North Lincolnshire, North East Lincolnshire and Greater Lincolnshire have all signed a paper agreeing to a Devolution Deal. Consultation will now follow.

Comments - Wrawby PC's previous comments still remain the same, but with the addition that should this application be approved, there is a perfect opportunity for the concerns regarding the narrowing of the footpath and cycleway on the A18 as the point it enters Brigg to be addressed.

The footpath and the cycleway needs to be widened to allow both pedestrians and cyclist to travel safely between Brigg and Wrawby.
