63. North Lincolnshire Council Ward Councilor update.

Cllr Nigel Sherwood gave the following report.

Unfortunately central government have instructed local authorities of raise their Council Tax by the full amount or the Council would lose its grants. This means that NLC Council Tax will raise this year.

Green badge scheme launched for temporary disability parking.

In Bloom Grants to be announced soon.

Air Fryers roll out – most have been delivered. Awaiting a delivery of a further 6000 to be delivered to anyone of a pensionable age who has requested this.

New diagnostic centre soon to be opened in central Scunthorpe. Hope to be by end of February.

Surfacing to Wrawby Roads to be completed this year.

Cllr Hebblewhite asked about the closed footpath at the Bellway development on Wrwaby

Road. Cllr C Sherwood said he would look into the highways conditions.

68. Environmental

a) In Bloom proposals

The in-bloom plans were discussed. It was agreed in principle to look into replacing the two planters near to the church. Cllrs Reddish and Hebblewhite said they could make them a lot cheaper than purchasing readymade ones. Will apply for grant when they become available. Agreed purchase of compost – approximately £120.00.

Hope to increase volunteers.

Will look into entering East Midlands in Bloom rather than CPRE BKV as very disappointed at judging when so much work had been undertaken to improve the environment in 2024.

b) Highways

Clerk updated on the response from NLC re Kettleby Lane and the concerns re HGV access during Bigby Road works. Cadent has been advised to add extra signs and police will enforce if HGVs found to be using the road, due to weight limit restrictions.

Cllr Hebblewhite updated on the working group meetings. Have met with three play park providers. Have received two initial quotes and are waiting for the third.

Looking into grant funding form NLC, Singleton Birch, and FCC.

If successful we will be able to place order and complete the works this year.
