In Bloom grants will be announced shortly following the scrutiny time allowed. The grant application time will be open until late April and will cover two seasonal grants in one.

Full Council budget meeting was held at North Lincolnshire, and it was agreed to keep the

free swimming for under 16s in Easter Holidays and Summer Holidays.
Imagination Library will continue. Its 1,000,000th book was issued just before Christmas.
Announced 2 free months for leisure centre membership for over 60s, at off peak times, to encourage fitness in the older generations.

Air fryers, slow cookers and one cup kettles will be distributed to those who have been notified in Wrawby on Monday 27th March, from Village Hall.

Highways works to Wrawby still on plan for 2025/2026 financial year.

Submission has been made to Government for Devolution of four Councils (North Lincolnshire, North East Lincolnshire, West Lindsey and East Lindsey will form a new Northern Lincolnshire Authority in 2028. The elections will take place in May 2027.
