25/69 North Lincolnshire Ward Councillors' Report and Councillors' questions to Ward Councillors.

Cllr N Sherwood updated that the highway works to Vicarage Road, Franklin Close and Little Lane scheduled to take place on 16th – 17th February.

The A18 Melton Road will be subject to Anglian Water Mains laying on 13th – 16th Feb and 20th - 23rd Feb. There will be two way traffic signals with complete closure at weekends.

The same at Kettleby Lane on 17th April.

He explained that this will delay the scheduled highway works to A18 but they are working hard to push for the works to be completed as soon as the AW works are completed.

The Toucan crossing has been approved Wrawby Road at the new Bellway estate and works will commence 9th Feb.

The change in bins and the red recycling bins is starting to be rolled out. Change to collections to start in April.

Lorry Park appeal has been agreed.

New rollout of Air fryers, slow cookers and one cup kettle will start on 9th Feb. register online or in the Brigg hub. 40-minute demonstration start on 18th Feb. Again, register at the Hub or online.

Cllr N Sherwood also updated on road works in Brigg in February.

Cllr Reddish asked if the church car park sweep and maintenance can be looked at again. It was swept but not satisfactorily.

Councillors were asked if there was to be any in Bloom grants this year.

Cllrs said that both questions would be looked into.
